

Frequently Asked Questions:

[How long will it take for my payroll deduction to start, or changes to go into effect?](#)

It will depend on the date of your pay cycle. Please allow up to two pay cycles for your donation to show.

[When will my deductions end?](#)

As long as you are an active employee, recurring deductions will continue until you cancel them.

Will my deduction come out of each paycheck?

Yes, this is a recurring donation that will be deducted from each paycheck. If you would like to make a one-time donation, you can make a credit/debit card donation online: <https://app.mobilecause.com/vf/MCKCARES>. Or, you can send a check made out to: Emergency Assistance Foundation, Inc. with “McKesson Taking Care of Our Own Fund” in the memo or the cover letter, and mail it to Dept # 9884, Emergency Assistance Foundation, PO Box 850001, Orlando, FL 32885-9884.

Where can I see how much has been deducted?

Your contribution will appear on the Post-Tax deduction section of your pay statement, along with your year-to-date total donation.

What is the minimum/maximum donation allowed?

Your contribution amount is up to you. There is no minimum or maximum for your contribution.

I don't see my deductions on my pay statement. Who do I contact?

Is my donation tax deductible?

Yes! Your donation is tax deductible in the U.S. to the full extent permissible by law.

Can donations be directed to a specific employee?

Regulations do not allow donations to be earmarked for specific employees. All donations go to the Fund to support as many McKesson employees as possible.

Do I have to contribute to the Fund to be eligible to apply for assistance?

Not at all. Donating to the Fund is completely voluntary. Eligibility for assistance is based upon need and qualifying circumstances.

Why should I donate to the McKesson Taking Care of Our Own Fund?

Every dollar you donate will help fellow employees who are going through difficult times. This is a wonderful way to live our ICARE values and make a difference in each other's lives.

How much of my donation goes to employees?

100% of your donation goes to fellow McKesson employees. The McKesson Foundation covers all operating expenses for the Fund.

Will McKesson match my gift?

The McKesson Foundation will automatically match your gift. You don't need to request a matching gift for donations to the Taking Care of Our Own Fund.
